### **EXPLANATORY NOTES TO THE INTERIM FINANCIAL REPORT FOR THE FINANCIAL PERIOD ENDED 28 FEBRUARY 2015**

#### **PART A: REQUIREMENTS OF MFRS 134 INTERIM FINANCIAL REPORTING**

##### **A1. Basis of Preparation**

The interim financial report is unaudited and has been prepared in compliance with MFRS 134, Interim Financial Reporting and the additional disclosure requirements as in Part A of Appendix 9B of the Revised Listing Requirements of Bursa Malaysia Securities.

This interim financial report should be read in conjunction with the Group's annual audited financial statements for the year ended 31 May 2014. These explanation notes attached to the interim financial report provides an explanation of events and transactions that are significant for an understanding of the financial position and performance of the Group since the financial year ended 31 May 2014.

**PART B: REQUIREMENTS OF PART A OF APPENDIX 9B OF THE REVISED  
LISTING REQUIREMENTS**

**B1. Review of Performance**

The Group recorded revenue of RM41.17 million for the current financial period ended 28 February 2015 reflecting a decrease of RM9.33 million or 18.48% when compared to the revenue of RM50.50 million in the preceding year corresponding period. The Group registered a loss before tax of RM0.38 million when compared to the profit before tax of RM4.70 million in the preceding year corresponding period. The result was mainly due to lower revenue in the current financial period and different product mix.

**B2. Variation of Results Against Preceding Quarter**

The Group recorded revenue of RM11.9 million for the current financial quarter ended 28 February 2015 reflecting a decrease of RM2.2 million or 15.6% when compared to the revenue of RM14.1 million in the preceding quarter ended 30 November 2014. The Group registered a loss before tax of RM0.56 million when compared to the loss before tax of RM0.31 million in the preceding quarter. The result was mainly due to lower revenue in the current financial period and different product mix.

**B3. Current Year Prospects**

Barring any unforeseen changes in the global economic climate and market conditions, the Group will continue to be cautious on the challenge ahead. The management will continue its effort in improving its operating results.

**B4. Profit Forecast**

Not applicable as the Company did not provide any profit forecast.
